You are aware that the Deputy Charity Commissioner, Greater Mumbai Region, Mumbai, has rejected five Change Reports, bearing Nos. 617 of 2008, 3188 of 2011, 2092 of 2011, 1738 of 2011 and 2587 of 2010. The Central Executive Committee elected for the year 2013-2015 is the only body authorized to hold Conferences for the Indian Association of Physiotherapists and the members are, therefore, requested not to participate in any such illegal election and/or Conferences as doing so may invite civil as well as criminal consequences according to law.
